It is further agreed that neither ZULULAND DEEP SEA ANGLING/RICHARDS BAY SKI-BOAT CLUB and/or AGENTS nor any of the members of the Committee of ZDSAA/RBSBC nor their agents shall be liable for any damages or injuries or loss arising as a result of any Bona Fide rescue operations, which operations shall be undertaken at the sole discretion of the rescuer and at the sole risk of the entity or person to be rescued. In this regard it is specifically agreed that no person shall be compelled or obliged to effect rescue operations, either on land or at sea, having regard to the sea or land conditions and various other circumstances that may pertain at any particular time. Where the value of human life prevails over the value of boat, craft, vehicle, equipment etc. the rescuer shall have the discretion to exercise the Modis Operandi which to him/her seems most prudent under the circumstances on land or at sea.
